


Keep up the great work everyone!


This is the front yard in fall at Kevin Kelly's award-winning garden in Lower Paxton Twp.

Do you love fig trees? The fig is a peculiar and underestimated fruit with a very rich history. For over a million years, over 750 species of fig trees shaped our world, influenced our evolution, and nourished our bodies and imagination. The fig is mentioned in every culture and religion!

Dr. Jafar Vossoughi, retired bioengineering professor and a Master Gardener, will present a comprehensive talk on the



small, unusual fruit, the fig. The presentation will cover history, botany, biology, and information specific to the cultivars suitable for our region. A short review of the medicinal, nutritional, and culinary aspects of this fruit will also be discussed.

#### **Tawes Garden**

Tawes Garden has had a busy
September. On September 14th, we
staged our second annual Tawes
Garden Native Plant Celebration. It
was a beautiful day to spend
outdoors in a tranquil setting. We
had a decent turnout for the event,
given the many competing fall
activities going on in the Annapolis
area that day. This year, the
Celebration had about a dozen
exhibitors, representing local
organizations which promote the
use of native plants to support



essential pollinators and wildlife. Some of those present were Project Butterfly and Bumblebee, Chesapeake Coastal Services, Watershed Stewards, Save Our Trees as well as Master Gardeners from the Native Pollinator and Composting groups. Visitors were able to talk with experts in the field of native plants, pollinator habitat, soil conservation, mature tree preservation and home composting. Many exhibitors had fun giveaways, in addition to informational brochures and landscaping suggestions. The undisputed stars of the Celebration were the almost 100 native plants which were generously provided by the Master Gardener Native Pollinator group. Everyone who attended that day went home with at least one native plant and several folks walked away with an entire tray. We've already started thinking about ways to improve outreach for next year's Native Plant Celebration.

October will be busy as well, with our Unity Gardens Planting Day scheduled for Wednesday, October 9th, starting at 8am. If any Master Gardeners are still in need of volunteer hours, we would welcome your help. This installation will be the fourth year of Unity Garden funding, in our ongoing effort to transition the Tawes Garden Plant Mural into a largely native plant demonstration garden. This year, we are targeting the entry area of the Plant Mural, replacing non-native grasses and invasives with native grasses and shrubs. We could use help on Wednesday, October 2nd as well, if any MG's are available. Hours are anytime between 8am and 12noon. Enter through the DNR building (photo ID required) and bring your own small tools. Parking is available directly in front of the building, located at 580 Taylor Avenue in Annapolis. Thursday, 10/29

Even if you don't feel like gardening, consider stopping by the Tawes Garden (now designated an official Maryland State Park, open dawn to dusk), where the Plant Mural showcases many fall-blooming plants with beautiful foliage and seed heads. Thanks to Unity Gardens funding and to the many hours put in by Tawes volunteers this year, the garden is looking great!

Mark your calendars too for an upcoming bus trip to the amazing holiday light and plant displays at Longwood Gardens, scheduled for Wednesday, December 4th. The bus trip will be a fundraiser for the Friends of Tawes Garden, a non-profit group which supports the garden. More details will follow soon in the Friday Flash. Last year's trip was a sell-out and this year, Longwood will be showcasing a huge new conservatory so it should be a very fun day.

# **Apprentice Gardens - Kinder Farm Park**

Apprentice Garden meets at the Kinder Farm Park community garden #105 in Millersville, **every Wednesday at 6:30PM**, from April through
September. At the close of September, the project officially ends for the season.

#### **Educational Outreach Activities**

 During September, meetings continued with the families to answer questions, and to work with them and offer advice regarding their summer crops. Some families wanted advice regarding planting fall crops.

#### **Volunteer Opportunities**

 Occasional work parties to complete the closing of the garden, including clearing debris, planting cover crop, cleaning and storing tools, and refreshing straw on the pathways.

#### **Accomplishments and Challenges**

About half of the Apprentice Garden spaces have been closed for the season. Crimson clover cover crop was planted in the cleared spaces,



and has begun to germinate. A few families planted fall crops and continue to tend them. Herbs from the Mediterranean garden, including rosemary, sage, lavender, thyme and chives will continue to be available throughout the fall.

The perennial flower gardens planted by the Master Gardener volunteers fared well throughout

the hot summer, including the swamp milkweed, native hibiscus, and a variety of rudbeckia along the outside of the fence. A passion flower vine has produced fruit. Thank you's to Kristin Silva, Kathy Albers, Wendy Boardman, Kathy Enderle, Deb Fritz, Lourdes Hergenroeder, and Susan and Lajauna Smouse.. Thank you, especially, to all our weekend waterers - the lack of rain has been a challenge.

All of the families, eligible to join the Apprentice Garden for a second year, are interested in joining us next season.

# Compost Demonstration Garden at Quiet Waters Park

September was a busy month at the Composting and Native Gardens project site. On Sept. 4th we welcomed three members of the county's Waste Management Recycling staff to our demonstration, along with other county residents. The employees of the Recycling program purchase and deliver compost bins for members of the compost project to give away at our demonstrations.



In addition to holding the demos, the compost team has been sprucing up the display area. Burlap and wood chips were added around some of the compost bins to hold down weeds and improve access. The fall flowers have benefitted from consistent watering and application of compost. At the next work session, we will be adding new natives obtained from Providence Center and Chesapeake Natives. You are welcome to join us for the remaining compost demonstrations at 10am on Wed. Oct. 2, Sat. Oct. 19 and Sat. Nov. 2. Concurrent MG/interns work sessions are from 9am-noon. Please let me know if you'd like more info or need directions.

- Late season natives have been providing sustenance for pollinators.










# **Ask-a-Master Gardener Plant Clinics**

This is the count of contacts made thus far in 2024. The Farmer's Market clinics will continue until October 12th at Crofton and Annapolis and through October at Severna Park.


The Teaching/Conservation Garden at Severna Park is still in the planning stage. We have contacted MDOT regarding several dead and dying trees that need to be removed before the actual labor begins. Maxine took soil samples and submitted them for testing. The report indicated the soil ph is acceptable, but we will need to add lime. Additionally, we will spread compost to amend and enrich the soil as preparation for planting. Volunteers are welcome and hours will be awarded. This is not a separate project; it is part of the Ask-a-MasterGardener Plant Clinic for Severna Park. Each stage of the construction will be used to teach the public about gardening from the ground up!

Signs will be posted regarding the process and maintenance. Planting day will be announced in the spring.
