UPDATES FROM THE 4-H OFFICE



As many of our 4-H volunteers know, the University has implemented a comprehensive background check policy for all new and returning volunteers. Most volunteers will receive an invitation from Sterling Volunteers to complete the online check and the cost will be \$15 every three years. The process is quick and easy, however, if you do have any questions or concerns, please feel free to contact our office. New volunteers were contacted first and returning volunteers will be contacted based on your last name, alphabetically beginning in April. Currently, we are up to the letter "L". If you are a returning volunteer and your last name begins with A-L and you have not received an invitation, please let us know as soon as possible.

If you plan to chaperone or work with Camp, you will need to be finger-printed and will not need to complete the online check. Instead you will be contacted by the State 4-H Office and given a code to use at your fingerprinting appointment. We realize this is a big change for all but rest assured it is being implemented not only for the safety of our 4-Hers but for our volunteers. Thank you to all of our volunteers for your continued commitment to our 4-H Program!

Conditions are improving and Covid 19 Restrictions are being relaxed! We are no longer requiring our volunteers to complete the Return to In Person Training to hold in person meetings or events. Approval of meetings are no longer required, however, the updated attendance record is still needed and should be uploaded to the portal within 48 hours of your meeting or event. Outdoor events have no size restrictions but masks are strongly encouraged for any individuals that are unvaccinated. Livestock Exhibitor Dress Code Change for the 2021 Harford County 4-H Fair:

All Exhibitors are expected to appear in the show ring in clean clothing that results in a neat appearance. You must wear the provided t-shirt. Pants may be clean jeans blue or black, non-distressed, no low rise, no holes, no tears, and no destructed look. Footwear must be closed toe shoes and/or boots. The Outdoor Superintendents and your Department Superintendents will enforce these rules.

Just a reminder, Health papers (CVI) and self certification papers must accompany each livestock animal upon entry to the Fairgrounds. 
Harford County 4-Hers Andrew

Restoring Maryland 4-H In-Person Programs

Baseline Conditions as of July 1, 2021.



LOCATION

4-H Activity may be held outdoors or indoors.

- Outdoors: Physical distancing restrictions have been lifted. Please continue to respect the personal space and comfort level of participants.
- Indoors: 4-H activity must comply with local school system directives on physical distancing.



DIRECTIVES

4-H Activity must comply with local directives for indoor or outdoor gatherings. Please note, some 4-H activities are required to follow additional guidelines (i.e. camp & overnight activities).



SIZE

There are no restrictions on capacity sizes. 4-H activity must comply with local school system directives on physical distancing. All 4-H activities must include at least 2 UME Volunteers or 4-H Faculty/Staff leaders. Please be mindful of 4-H youth/adult ratios.

- 1 adult volunteer for every 10 youth ages 8-18.
- 1 adult volunteer for every 5 Cloverbud members ages 5-7.




HEALTH PLEDGE

All youth and adult participants must affirm they are well enough to participate in the 4-H activity when signing the attendance form for the 4-H activity. Individual health pledges will no longer be required.



FACE COVERING

- Outdoors: 4-H, as guided by the Maryland Health Department, strongly recommends that all non-vaccinated individuals over the age of 2 continue to wear face coverings in all outdoor settings where physical distancing cannot be maintained.
- Indoors: 4-H activity must comply with local school system directives on mask requirements indoors.



PHYSICAL DISTANCING

4-H activity must comply with local school system directives on physical distancing.



HAND HYGIENE

All 4-H Activity participants must have access to supplies for hand hygiene (hand sanitizer, sink with soap and water, etc).



CLEANING

Cleaning and sanitizing supplies must be available. High-touch surfaces and shared equipment or materials must be sanitized.
