3. Must be physically capable of lifting and moving light to heavy exhibits and objects over short distances. Must be able to climb in and out of exhibit areas. Must be able to climb into/out of animal pens.
4. Must have a friendly, respectful demeanor, be enthusiastic about the fair and 4-H and be able to interact positively with youth, UME and MDSF faculty and staff, volunteers and the public. Must be appropriately dressed and maintain a clean and neat appearance at all times while on duty. Must wear the provided t-shirt and keep t-shirt clean.
5. Must provide own transportation to the fair.
