The deadline to submit your Annual Implementation Report (AIR) is March 1, 2023. The report outlines nutrient applications made in 2022. Paper reporting forms will be mailed to regulated farmers in January and posted on the website. Pressed for time? File your report electronically. Last year, more than 30% of regulated farmers took advantage of this time-saving reporting option. To e-file your report: go to onestop.md.gov and browse the state agencies for the 2022 AIR reporting form. Follow the instructions to set up your account and complete your report.
