#### Market Swine Weigh-In

Market Swine Weigh-In will take place on **Friday, May 5th from 5-9pm** in the TRP Barn at the Ag Center. If you have any specific questions about weigh-in, please contact the Extension Office or one of the Swine Committee Members. Please remember to check all of your paperwork prior to leaving weigh-in. Once you leave the Ag Center, we will not be able to make any changes.

Castration Policy of the Maryland 4-H AnSc Program: All male steers, lambs, pigs and goats must be neutered and healed prior to 4-H weigh-in and tagging. The only exception would be animals that have obvious signs they have been banded, however, their scrotal sac is still intact.

#### Market Sheep and Meat Goat Tagging and Weigh-In

If you plan to exhibit one of the above animals at the county or state fair, it must have a Maryland 4-H ear tag and be weighed in Carroll County. You must turn in a completed 2-part form to the Extension Office with the number of tags you will need by May 5th for Lambs and Goats (Weigh-in date – Friday, May 12<sup>th</sup>, 5-8 P.M.). Remember to fill in ALL information, including RFID/Scrapie tag numbers. The Animal Science Code of Ethics will be on the reverse side and BOTH pages must be signed. There will be a total of 3 signatures for the 4-Her and 3 for the parent/guardian. Tags cost \$2 each for lambs and goats. Checks can be made payable to CCEAB. You must register, tag and weigh-in the appropriate animal for Carroll County. You may not weigh-in your animals at another county and be eligible for the Carroll County 4-H/FFA Fair. Questions? Castration Policy of the Maryland 4-H AnSc Program: All male steers, lambs, pigs and goats must be neutered and healed prior to 4-H weigh-in and tagging. The only exception would be animals that have obvious signs they have been banded, however, their scrotal sac is still intact.

#### **Livestock Judging**

Are You Ready? The next practices will be on **May 11th and May 31st at 7pm at the Extension Office.** We will be starting with the basics: parts of the steer/heifer, gilt/barrow, ewe/lamb and moving on to why it's important to know these parts and how it helps to talk about the animals. In later sessions, we will watch some videos of these animals and learn how to see the good, the bad and the ugly in the 4 animals in the class. Starting in June, we will travel to area farms and judge the animals live and in person.

#### **Horse Safety Class**

If you are a 1st year Horse Exhibitor, you are required to attend one of the horse safety classes offered. Exhibitors will learn about horse safety, along with an orientation about what happens on show day at the fair and what you need to bring. If you haven't already attended an earlier class, the last one being offered is on May 8th at 7 P.M. at the Extension Office.



#### Livestock/Horse Lease Forms

If you are planning to lease a livestock or horse animal project this year, make sure you complete the 4-H Lease Paperwork. There is a lease agreement that is completed between the 4-H member and the individual leasing the animal to you. #### Horse Rulebook and Bit Guide for 2023

The Maryland 4-H Horse Program has updated the Maryland 4-H Horse Show Rulebook. Additionally, in order to provide education and clarification on acceptable bits and bridles, a Maryland State 4-H Bit and Bridle Guide is available. This guide should help exhibitors to understand what bits are and are not acceptable for given classes before coming to a Maryland 4-H show. #### **Poultry and Rabbit Registration Forms**

The Poultry and Rabbit Registration Form is REQUIRED for those exhibitors planning to exhibit at the county and/or state fairs. Please fill out the form attached (online only) and submit to the CC Extension Office by **June 1st.** 

#### **Poultry Orientation**

If you plan to OR are thinking about entering in the Poultry department at the 2023 Fair, you will need to attend one of the orientations. The last one being offered is scheduled for **Thursday, May 4th at 7 P.M. at the Extension Office.** You need to attend if you think you are going to show poultry, eggs, a poster and if you are a clover. This includes first year exhibitors or returning exhibitors. These orientations will explain entering, knowing what breed you have, expectations of you during fair week, what to expect from the poultry committee during fair week and the ever-changing fair schedule. It is nearly certain that there will be lots of changes in the schedule for this year. If you showed in the Poultry Department in 2022, you are required to have completed a Poultry Project Record in order to exhibit in the 2023 fair (Clovers exempt). There will not be ANY make up orientations and there will not be ANY online opportunities to complete the orientation. Please do not put off attending this last orientation. Remember you are required to attend 1 (one) of the in-person orientations in order to exhibit. Any questions, please call Nancy Carlisle at 443-605-5134.

#### **Animal Quality Assurance**

If you are a new member or have moved to a new age group (Junior to Intermediate, Intermediate to Senior), you are required to take the online Quality Assurance Program this year. The online program is required for ALL 4-H members showing beef, dairy, swine, sheep, goats, horses/ponies, poultry, rabbits and alpacas/llamas. An email will be sent when the website is opened by Maryland 4-H. (<a href="https://ahqa.umd.edu/">https://ahqa.umd.edu/</a>) You will need to register and complete this program if you are planning to show at any 4-H show. **2023 Fair Dates**—July 29—August 4, 2023 **2023 Fair Theme**—The Power of YOUth

**Indoor Building Updates:** Plans continue for the 2023 Carroll County 4-H & FFA Fair. This month I will cover two departments. I will start with the **Home Environment Department** because changes have been made to the wording in many classes. Please read the complete descriptions of the classes in the fair catalog online. These changes should make classes clearer for 4-Hers entering.

The second department is the **General Department**. There will be a special award given to the champion Vet/Animal Science project. Anyone who enters the Vet Science or Livestock Class in the General Department will be considered for this award.

At the March Fair Board meeting, a vote was taken on the processing fee. There will be no processing fee for the 2023 County Fair. It will start with the 2024 County Fair. As a 4-H leader for many years, I would advise my club members that whatever they might want to enter at the fair needed to be preentered in those classes by the entry deadline. That mindset needs to be changed. Just as businesses see their expenses increasing, so does the Fair Board. The cost of processing entries is increasing. We want our 4-Hers to enter all of their exhibits and we want our buildings full of exhibits. For the example, if a flower or item in garden products hasn't been planted by the fair deadline date, it wouldn't be big enough in bloom or ripe enough to exhibit at the fair. So, there would be no reason to enter that item in the county fair.

Each pre-entered item in the fair costs the fair \$0.25. So if a 4-Her was to enter all 76 classes in the crafts department, the fair would be paying \$19 for those pre-entered items. As much as we would love to see a member enter all 76 classes, that most likely is not going to happen and is costing the fair in the end. Then multiply the money spent on hundreds of pre-entered items that don't show up fair week. Also, take the time to consider what projects you may actually complete to enter in the fair and remember there is a simple substitution system within the indoor departments. You can take an entry tag in crafts, change the class number and name and then attach it to the exhibit. However, substitutions can only be made within the same department.

An update for club entries –The plan is to not have entry tags for most club entries. Next month I will conclude with the Foods Department.

- 1. Junior contestants (ages 8 to 10) may model only one outfit. Intermediate members (ages 11 to 13) may model two outfits one from Constructed and one from Ready to Wear. Senior members (ages 14 to 18) may model two outfits, but no more than one outfit per class.
- 2. Participants must participate in both the Preliminary and On-Stage Judging portions of the event.
- 3. Senior champions will represent Carroll County at the Maryland State Fair. Intermediates and Juniors can model only at the Maryland State Fair. 4-H members are responsible to registering themselves into the Maryland State Contest by July 15<sup>th</sup> at www.marylandstatefair.com
- 4. Each participant will need to arrive between 3-5pm on June 10th for modeling/interviewing with the judges. Times will not be assigned and it's the responsibility of the participant to arrive during the judging time listed above.
- 5. All classes except Ready to Wear are constructed by the 4-Her using a sewing machine, hand stitching, weaving, knitting or crocheting. These garments are completed as part of the Sewing/Textiles unit. As in the past, the entire outfit does not have to be home constructed,

unless described as a requirement for the class. Construction is judged only as it affects the appearance of the outfit on the model.

- 6. Ready to Wear classes are garments constructed by a manufacturer. No home-constructed items may be entered in these classes. Garments do not have to be purchased new and can be altered. You are encouraged to follow class descriptions as you select the appropriate class for your entry.
- 7. Accessories do not need to be made by the contestant, but will be taken into consideration in judging the overall presentation of the outfit. Accessories must be easily worn or carried. No live animals or people as accessories.
- 8. No one will be permitted on stage or in the judging room area unless pre-entered in the County Fashion Revue event.

By not providing all requested information, an individual may not receive materials associated with the project and may not be permitted to participate in shows in which animals must be tagged with the Maryland 4-H Livestock Tag.

#### University of Maryland Extension (UME) 4-H Code of Animal Science Ethics

4-H members enrolled in animal science projects (e.g., beef, camelids, dairy, dog, goat, horse, poultry, rabbit, sheep, small pet, and swine) shall, at all times, conduct themselves with honesty and good sportsmanship, including while with their projects and at all 4-H animal science activities and events. Their conduct should always reflect the highest standards of honor and dignity to promote the advancement of 4-H and its animal science program. 4-H members, as well as parents, UME volunteers and others working with them, are under an affirmative responsibility to do more than avoid improper conduct or questionable acts; and their conduct and values must serve as a positive influence on others.

This Code of Ethics applies to all 4-H members who are enrolled in animal science projects, and to others (4-Hers, parents, volunteers, owners, etc.) who participate in the animal science program; and it covers daily animal care, as well as participation in competition and other 4-H animal activities and events.

4-H members and others who violate this Code of Ethics demean the integrity of 4-H and its animal science program. 4-H members who violate the code of animal science ethics are subject to sanctions including, but not limited to, forfeiture of premiums, awards, and/or auction proceeds and may be prohibited from participation in 4-H or 4-H/UME events or activities; other violators may also be subject to sanction, as appropriate. Infractions may be reviewed by 4-H and/or UME (on the local or state level, as appropriate to the infraction and to the event and/or activity in question), and/or may be subject to a fair oversight committee or other entity that oversees an activity or event. In addition, some acts may also be subject to review based upon the *Maryland 4-H Youth Code of Conduct* and/or other UME policies.

The following is a list of standards and requirements for all 4-H animal science projects, at all times, whether at home, at animal exhibitions or events, or any other 4-H event or activity.

- 1. The care of all 4-H project animals is the responsibility of the 4-H member. 4-H members must properly care for and groom their animals for the duration of their project.
- 2. All project animals must be housed at the 4-H member's residence unless a different location is submitted to and approved in writing by the local 4-H staff. Any change in location must be approved in writing by the local 4-H staff, however, it is not necessary to report direct transport to and from shows or other events.
- 3. Upon request of 4-H, UME, or other program, fair, event or animal officials, 4-H members must present proof of ownership, length of ownership, identity and/or age of all 4-H project animals owned or leased. Misrepresentation of ownership, age, or identity of animal, or any facts relating thereto is prohibited. If a 4-H project animal is sold in a livestock sale, it is no longer eligible to be shown in a 4-H event in Maryland in that year.
- 4. 4-H members must provide appropriate animal health certificates upon request of 4-H, UME, or other program, fair, event or animal officials.
- 5. 4-H project animals must be presented to competition, activities and/or events, where they will enter the food chain, free of volatile drug residues. Animals which are presented to competition, events and/or activities that do not culminate with the animal entering the food chain, shall not be administered drugs other than in accordance with applicable federal, state, and local laws, regulations and rules. 4-H project animals shall not be exhibited if drugs administered in accordance with federal, state, and local regulations and rules may affect the animal's performance or appearance at the event. At any time after an animal arrives on a fair or other 4-H activity or event premises, a licensed veterinarian must administer or, in consultation with fair, event, UME, or 4-H officials, direct the administration of any treatments involving the use of drugs and/or medications. Drenching at any time after an animal arrives on a fair or other 4-H activity or event premises is prohibited, except when performed or directed by a licensed veterinarian in consultation with fair, event, UME, or 4-H officials for the sole purpose of protecting the health of the animal.
- 6. The act of enrolling in a 4-H animal science project, and/or entering a project animal in a 4-H competition, show, activity, or other event, gives consent for 4-H or UME or event authorities to obtain any specimens of urine, saliva, blood, hair, tissue, or other substance from the animal to be used for testing purposes including, but not limited to, drugs or identification. It is presumed that the sample of urine, saliva, blood or other substance tested by the approved laboratory to which it is sent is the one taken from the animal in question, its integrity is preserved, and all procedures of said collection and preservation, transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample was taken, with the burden on the 4-H owner to prove otherwise at any review in regard to the matter conducted by a fair or other event or the 4-H program. If the laboratory report on the chemical analysis of saliva, urine, blood, hair, tissue or other sample, taken from a 4-H animal science project, indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally.
- 7. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counter irritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance, except external applications of substances to the hoofs or homs of animals which affect appearance only and except for surgical procedures performed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 8. Using ice, ice packs, cold packs, or cold compresses, internally or externally, other than those prescribed to relieve heat stress or a medical condition as diagnosed by a duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.
- 9. The use of showing and/or handling practices or devices, such as striking animals to cause swelling, using electrical devices, or other similar practices, are not acceptable and are prohibited.
- 10. All judges, fair and event officials and/or UME/4-H staff and volunteers shall be treated with courtesy, cooperation, and respect, and no person shall direct abusive or threatening conduct toward them or toward exhibitors or others participating in the activity. In addition, direct criticism or interference with a judge, fair, show or event official, exhibitor, breed representative, or UME/4-H staff or volunteer before, during, or after an event or other activity is prohibited.
- 11. No one shall violate this Code of Animal Science Ethics or conspire with another person or persons to intentionally violate this Code of Ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this Code of Ethics.
- 12. The application of this Code of Ethics provides for absolute responsibility for an animal's condition to the 4-H member whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this Code of Ethics.
- 13. By enrolling in an animal science project and/or entering an animal in a fair or other 4-H event or activity, the 4-H member, and his/her parent or guardian, consent to have disciplinary action taken by appropriate authorities (including UME, 4-H, fair, event and/or other activity officials) for violation of this Code of Animal Science Ethics and/or any other applicable rules of UME, 4-H, a fair, activity or other event, without recourse against UME, 4-H and/or other authorities. In addition, the 4-H member, and his/her parent or guardian, further understand and agree that any action which contravenes these rules, and is also in violation of federal, state, or local laws, statutes, regulations, or rules, may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

By signing this form the 4-H member and his/her parent or guardian each verify that they have read and understand the UME 4-H Code of Animal Science Ethics and the consequences of and penalties provided for violations of the Code.
