QUESTIONS WE NEED TO ASK A PRODUCER WHEN THEY ARE REQUESTING FINANCIAL ASSISTANCE....

- Roasters or Broilers
- Number of birds/flock
- Average weight
- Days/flock
- Flocks/year
- Size of Houses



FINANCIAL ASSISTANCE



- Federal Financial Assistance
 - NRCS (Natural Resource Conservation Service)
 - Typically through the Environmental Quality Incentives Program (EQIP Program)
 - Financial assistance is based on regional rates
 - All FA pay out is done through Direct Deposit
 - Continuous Sign-Up; Funding Period Typically Jan.-June
 - Must have eligibility through Farm Service Agency
 - Provide basic information about your operation and personal information

ENERGY AUDIT

Energy Audits for Poultry

- Typically, a two year process from sign up of Audit till begin installing practices.
 - Year 1: Apply for cost share to have Audit Written from Certified TSP
 - Year 2+: Apply for cost share on practices recommended in Audit (30 Yr. or less)
- Cost Share amount calculated using Animal Units/Size of Operation (Total Bird # per flock/1000 x Avg. bird weight)
- Certified Technical Service Provider that will use the ASABE & NRCS standards.
- We have contact information in the office for TSP's.

OVERVIEW OF AUDIT PROCESS

Step 1: Sign NRCS contract

Step 2: Contact Technical Service Provider and sign a contract.

Step 3: Provide Technical Service Provider with bills, invoices, etc.

Step 4: On Farm Site Visit with Technical Service Provider

Step 5: Audit will be mailed to the producer and a copy sent to NRCS.

COST SHARABLE ITEMS IN AUDIT

Lighting (Any recommendations in your operation)

Dimmer Control, if needed

Exhaust Ventilation

Radiant Tube Heating

Attic Insulation

Wall Insulation

Tunnel Doors



HUA PADS

To qualify there must be a resource concern present or pads must be called for the in applicants CNMP (Comprehensive Nutrient Management Plan).

Financial Assistance is a flat rate paid per sq. ft. of project.





CRITICAL AREA PLANTING

This practice is usually done in conjunction with

- HUA Pads
- Drainage Pipe
- Cover between and around poultry houses



TREE AND GRASS PLANTINGS

If trees are located within 100 ft of poultry house

- We can cost share on containerized stock
- Typically plant 'Green Giant' Arborvitae, Cedar, Euonymus, 'Nelly Stevens' Holly, different varieties of Switch Grass
- Must be irrigated for
 - 3 years
 - List of Contractors to Machine Plant or
 - Hand Plant Trees





TREE AND GRASS PLANTINGS CON'T

If trees are planted further than 100 ft of poultry house

- We can cost share on bare root plantings.
- Examples: Loblolly Pine, Eastern Redbud, Cedar, variety of shrubs



LITTER AMENDMENTS

Litter Amendments - help to reduce ammonia in poultry houses to improve air quality, and reduce air emissions.

NRCS Cost Share for Litter Amendments:

- 3 payments over 3 years (Example: after 4th, 8th and 12th flocks are treated)
- Participant can only sign up for this practice for one 3 year contract.

TYPES OF LITTER AMENDMENTS




COMPREHENSIVE NUTRIENT MANAGEMENT PLANS

A CNMP is a document comprised of a Conservation Plan, Nutrient Management Plan and Implementation Schedule of Practices needed on an animal feeding operation.

NRCS currently offers cost share for Technical Service Provider to write a CNMP. OR you can contact your local Soil Conservation District for help with writing a CNMP.

The purpose of a CNMP is to address current or potential resource concerns on an operation, and for CAFO/MAFO's to remain in compliance with MDE.



MACS

(<u>M</u>aryland <u>A</u>griculture <u>C</u>ost <u>S</u>hare)

MACS Cost Share \$

- The State of Maryland uses flat rates based on regional rates.
- State cost share is a re-imbursement based on a percentage of the flat rate, and the invoice for the completed project.
- All cost share is paid by a check from the State of Maryland.



POULTRY WASTE STORAGE STRUCTURE (PWSS)

Size determined by number of birds 87.5 % of flat rate



DEAD BIRD COMPOSTING FACILITY (DBCF)

Bin or Channel Attached or Unattached 87.5% of flat rate Size determined by number of birds



HEAVY USE AREA (HUA) CONCRETE PADS

Pays 87.5% of flat rate (currently \$10/sq ft) \$75,000 cap per operation Maximum pad size: 1600 sq ft.


CO-COST SHARE

NRCS and MACS can co cost share on some practices.

NRCS will provide a flat rate of cost share.

If there is a balance remaining after NRCS cost share, MACS will pay 87.5% of remaining balance.
