## Changes to the Nutrient Management Program



On June 1, our office was made aware that MDA has made the decision to cut funding to the UMD Nutrient Management program. As of August 31, our Nutrient Management Advisor, Jill Hauser will no longer be writing nutrient management plans for clients on behalf of UMD.

**MDA is developing a cost-share program** that will provide partial funding to all eligible farmers in Maryland to help offset the cost

of privatized plan writing. We will continue to assist producers to the best of our ability. Willie Lantz, AgFS Educator, will be announcing upcoming meetings with producers to discuss next steps.

23 4-H members recently completed their 2023 Broiler Project with the Broiler Show on June 5. Members were given 10 Cornish Cross peeps donated by Bruceton AG Service in Grantsville, MD. The members then raised the peeps for 8 weeks to a market size. At the end of the 8 weeks, the youth submitted a report showing the feed conversion, mortality rate, and profit/loss from their project. They included pictures and a story where they explained what they learned from their project. The members are then allowed to sell the broilers for meat or keep them for their families.

The Broiler Project is a wonderful, short term learning experience for 4-H youth and their families. We greatly appreciate the support of Bruceton AG Service for the donation of the broiler peeps to the youth members.

The youth participated in the following activities this year.

- 4-H STEM Challenge achieving neutral buoyancy of a submarine submerged
- Circuitry to learn about electricity making a simple and parallel circuit
- Snow Globe Science with a lesson on viscosity and pine identification
- Reverse Painting using critical thinking skills using layers in reverse
- Earthquake Challenge with a lesson on geography and an engineering challenge
- Edison Robots where students created their own challenges using concepts of obstacle detection and artificial intelligence
- 3D Design with a lesson the on the invasive pest Spotted Lanternfly.

### Farm and Food Workers Relief Program



Farm workers and meat packers may be eligible to claim a \$600 payment for their work during the <u>COVID-19</u> pandemic.

This \$600 payment is being administered by the Pasa Sustainable Agriculture non-profit, which is working with the U.S. <u>Department of Agriculture</u> to distribute these payments through the <u>Farm and Food Workers Relief Program</u>. In total, eligible farm workers in 13

states, including Connecticut, Delaware, Maine, Maryland, Massachusetts, New Hampshire, New

Jersey, New York, Ohio, Pennsylvania, Rhode Island, Vermont, and West Virginia, along with the District of Columbia, can <u>claim this payment</u>.

Applications for this payment opened on March 1, and will remain open until the funds for this payment are depleted.

To be eligible for this payment, a claimant must provide photo identification and proof they were employed as either a farm worker or meatpacking worker in the United States between January 27, 2020, and April 11, 2023.
