The main purpose of the meeting was to elect a board of directors for the newly formed organization. Board members will serve a one-year term as the initial board of directors. Jen Thomas was elected to serve as the vice chair. A committee was established to review the organizations by-laws and report back to the next meeting.

It was voted to hold meetings quarterly on the 2 nd Thursday of the month starting at 4:30pm. The meetings will be held at various locations throughout the area and a zoom option will be provided. No-Till Drill & Lime Spreader Rentals



The Garrett Soil Conservation District has begun rental of their No-Till Drill and their Lime Spreader for the 2024 season. The cost to rent the Drill is \$10 per acre. The Spreader is \$3 per ton. The No-Till Drill is a JD 1590, weighing approximately 7,500 lbs. Movement of the drill requires a tractor or truck equipped with a

hitch with adequate towing capacity. A minimum of a 85 PTO horsepower tractor is recommended. For more information about rentals, please go to https://garrettscd.org/agriculture or call 301-501-5886.

Manure Transport

The Maryland Department of Agriculture is reminding farmers they may apply for cost-share funding to help cover the cost of transporting all types of manure to crop fields with acceptable



soil phosphorus levels. Grants are also available to offset the cost of injecting liquid manure into soil to prevent nutrient runoff and reduce odors.

Program highlights include:

- Transporting poultry manure to qualifying fields with acceptable soil phosphorus levels or alternative use projects that can safely utilize the product; farmers may receive up to \$28/ton.
- Cost-share grants are available to transport dairy and livestock manure to qualifying fields, covering up to 87.5% of eligible costs.
- FastTrack and standard transport options are available for both poultry and dairy or livestock manure.
- Farmers may receive up to \$45/acre for costs associated with injecting liquid manure into the soil. Please note, poultry manure is not eligible for this option due to its low moisture content.

DMC continues to offer protection to dairy producers when the difference between the all-milk price and the average feed price (the margin) falls below a certain dollar

amount selected by the producer.
